5. Electronic bids must be submitted to the office Patan Municipality, Office of Municipal Executive through PPMO website www.bolpatra.gov.np/egp on or before 12:00 PM on 2078/10/14. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 Noon on 2078/10/14 at Patan Municipality, Office of Municipal Executive. Bids must be valid for a period of 90 days after bid opening and must be accompanied by scanned copy of the bid security in .pdf format, amounting to a minimum of Nrs. 3,75,000.00 (Three Lakhs Seventy Five Thousands Only), which shall be valid for 30 days beyond the validity period of the bid (i.e. 29 May 2022)
