The Government of Nepal [GoN] and Patan Municipality has allocated funds towards the Construction of Municipality Office Building Phase II and intend to apply part of the fund to cover eligible payment under the Contract No. NCB/PTNMUN/W-10/077/78. Bidding is open to all eligible Nepalese Bidders.
2. Patan Municipality invites electronic bids from eligible bidders for the **Construction of Municipality Office Building Phase II, Patan Municipality, Ward no.-6, Baitadi** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
3. Only eligible bidders with the following key qualifications should participate in this bidding. At least 1(one) 2 -Storey Framed Building construction Project within the last ten(10) year with the value of at least NRs.3,00,00,000.(without VAT) that have been successfully or are substantially completed. RCC Works at least M20 150M3 ,Reinforcement 30 Mt ,Form Work 1000M2.
4. Bidders, submitting their bid electronically, should deposit the cost of bidding document of a non-refundable fee of Rs.5,000 in account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

5. Pre-bid meeting shall be held at Patan Municipality Office at 16:00 pm on 24 May 2021.
6. Electronic bids must be submitted to the office Patan Municipality through PPMO website www.bolpatra.gov.np/egp on or before 12:00 noon on **4 June 2021** . Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 pm on **4 June 2021** at the office of Patan Municipality. Bids must be valid for a period of 120 days after bid



opening and must be accompanied by scanned copy of the bid security in pdf format amounting to a minimum of Rs.7,00,000.00 , which shall be valid for 30 days beyond the validity period of the bid .

8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.

9. The Office of Patan Municipality, Patan, Baitadi reserves the right to accept or reject any bid, and to annul the process and reject all bids at any time prior to award contract.

10. If any provision of bid document is inconsistent with Public Procurement Act (PPA), 2063 and Public Procurement Regulations (PPR), 2064, the provision of bid document shall be void to the extent of such inconsistency and the provision of PPA and PPR prevail.
